Vision

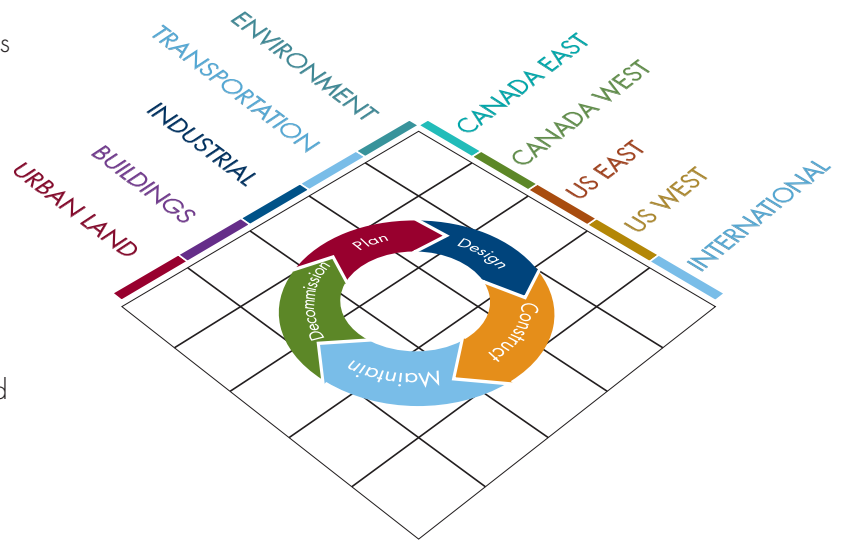
