KAVIK-STANTEC has extensive experience providing environmental solutions for industry, territorial, and federal regulatory agencies, co-management organizations, and communities in the Inuvialuit Settlement Region.

Nunami is a majority Inuit-owned consulting company providing services throughout Nunavut. Nunami's majority shareholders are the Sakku Investments Corporation (Sakku), which is owned by the Kivalliq Inuit Association and the Kitikmeot Corporation (KC), which is the business development arm of the Kitikmeot Inuit Association. Stantec is the minority shareholder and legal operator. Both Sakku and KC are focused on developing a sustainable economy which provides opportunity for Inuit. Nunami's head office is located in Rankin Inlet, Nunavut.

The partnership brings together the local presence and experience of Sakku and KC with the technical capabilities and experience of Stantec to deliver quality engineering and environmental solutions to Inuit, public and private sector clients and create value for beneficiaries of the Nunavut Land Claims Agreement Act. Building capacity through education, training and employment

Training

Through our Partnerships, we strive to continually build capacity in communities. We support on-going education and training through scholarships, training programs, and skills workshops. Examples include:

BUILDING ENVIRONMENTAL ABORIGINAL HUMAN RESOURCES TRAINING PROGRAM (BEAHR)

Stantec is a certified member of ECO Canada, a not-for-profit industry-led human resources organization that is dedicated to building Aboriginal careers in the environmental field. ECO Canada is committed to providing training for BEAHR programs to strengthen relationships with Indigenous communities through the facilitation of employment focused programs.

MARINE MAMMAL OBSERVER (MMO)

The MMO training program, developed and delivered by KAVIK-STANTEC, is intended to provide Inuvialuit MMOs and field technicians for industry and government offshore seismic and research projects. The program has trained a total of 478 Inuvialuit beneficiaries and provided seasonal employment for many of the graduates. Many of the MMOs have participated in multiple training programs and worked on a number of projects.

Health, Safety, Security, and Environment (HSSE)

Safety is a priority that benefits everyone. Our Indigenous Partnerships adhere to Stantec's HSSE policies and practices. It is our policy to ensure through leadership and training that HSSE is fully integrated through all phases of project planning and execution. Stantec provides HSSE training and specialized personal protective equipment to all employees.

CAPACITY BUILDING

A mandate of Stantec's partnerships is to build capacity. Where available, we procure goods and services locally to support the local community. Examples of the services that can be used, but are not limited to:
