Gather data to rank suppliers and review supplier selection processes. Investigate topics including sourcing methods, energy usage, labor practices, and waste management. Identify risks, gaps, and opportunities related to ESG standards.



Program Development:

Identify material risks, evaluate stakeholder interests, and engage in executive education. Ensure regulatory compliance tailored to geography and sector.
